

Edit form Deduplication functionalities (editable mockups)

If you want to propose changes to the following mockup please proceed as follow

- clone this page
- edit the cloned page: you will be able to edit the embedded balsamiq mockup
- add a **comment in the parent page** referencing to your own version of the mockup (the cloned page)

During the submission, after that has been edited some configurable fields (e.g. title or identifiers), the system check the item signatures to find potential duplicates. If any potential duplicate is found a popup is shown to the submitter asking to confirm or reject the result.

If the workflow is enabled the controller will see the same alert popup. If the submitter has declared that the match was a fake they can confirm or flag the record as necessary to merge so to have it highlighted in the administrative UI.

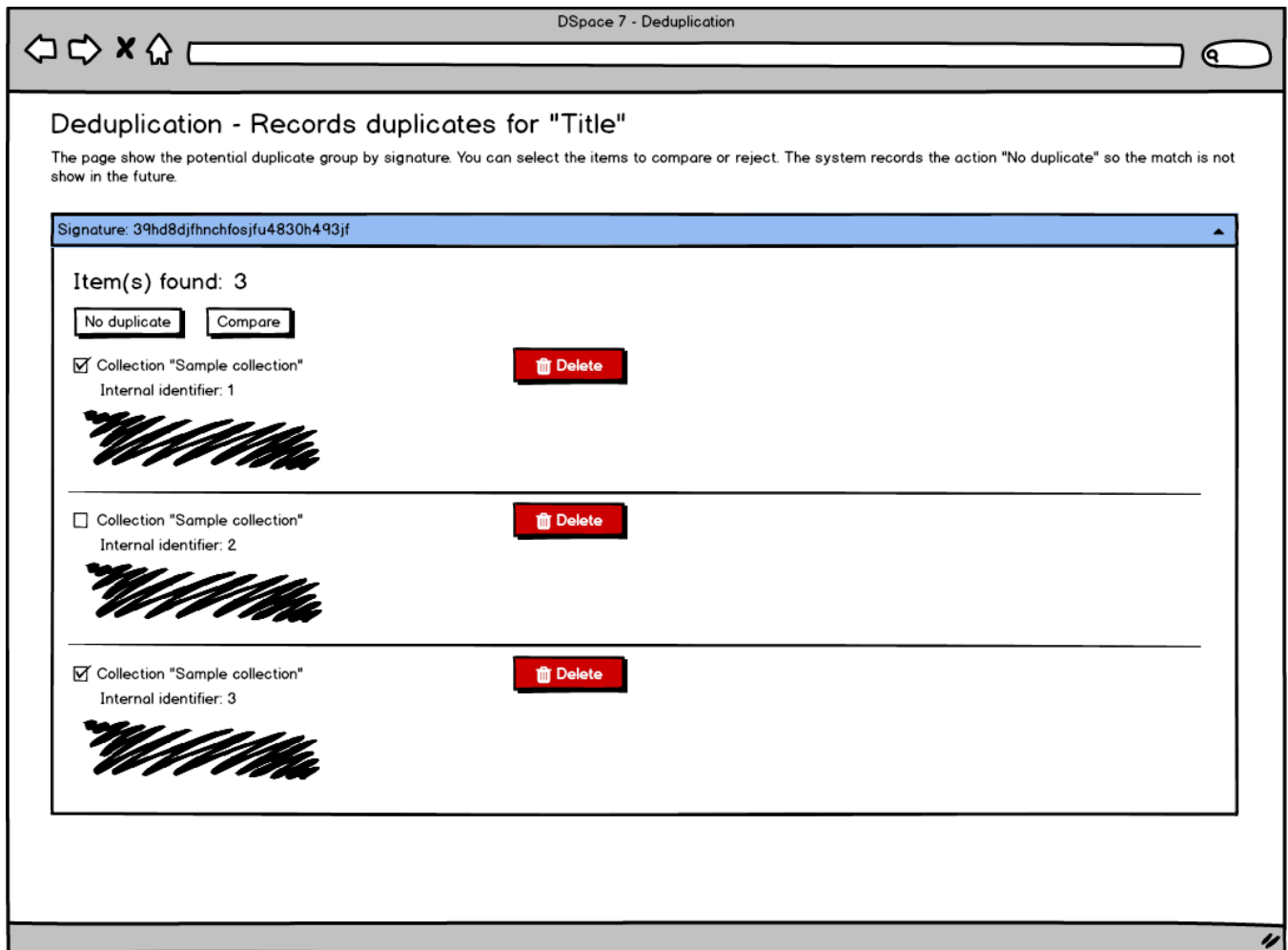
